SUBJECT: Justification for Other than Full and Open competition – Sole Source Request


In accordance with Federal Acquisition Regulations, Part 11.105, I am requesting your approval for a "Sole Source Justification ". The following facts and rationale are presented for your consideration in accordance with FAR11.105.

1. I request the following purchase as a Sole Source purchase for the following reasons.
 - a. This requirement is for specific brand name materials. This requirement is only available from the manufacture, Troy Acoustics Corporation and is not available for quote on a competitive basis.
 - b. The Troy System is currently the only sound mitigation material that has been tested and approved for use on AF ranges.
 - c. The following key points should also be considered in justifying procurement of Troy Acoustics Corporation's solution for this requirement:
 1. The Troy System assures that the range meets noise exposure limits as specified in OSHA(Occupational Safety and Health Administration) guidelines as well as the shooting Range ETL (Engineering Technical Letter) published by the US Air Force.
 2. This system has been tested by the US Air Force at Lackland Air Force Base to handle anti-ricochet and anti-splatter of errant rounds.
 3. The Troy System was proven to replace two layers of marine grade plywood and can be used for indoor and outdoor application.
 4. The Troy System panels are made of nonflammable, providing a safer environment if tracers are fired.
2. The following Market Research was accomplished:
 - a. The US Air Force Combat Arms Program Manager was contacted and he himself stated that the Troy system is the only system tested and approved for use in US Air Force firing ranges.
3. Price is considered to be Fair and Reasonable based on:
 - a. The proposed equipment from Troy Acoustics Corporation is comparable in price and scope to the sound deadening baffles used in US Army contract W52H0907P6046 from the same company.


